Eligibility criteria:-

- i) Candidates should pass HSLC/Equivalent Examination from a recognized Board/Council.
- ii) Candidates should attain 17 years and shall not exceed 25 years of age as on 1st May 2014. The upper age limit is relaxable for 3(Three) years in respect of ST/SC/OBC candidates.
- iii) The venue of the examination shall be made available at the time of issue of admit card.

The in-service employees of the Department who has been serving for more than 5(Five) years on regular basis and possessing the above qualification may also apply through proper channel in the prescribed format.
